## **TMTA Vice-President for Student Activities Annual Report**

The success of the TMTA Convention Student Activities and Student Affiliate programs this year has been a team effort. The TMTA Officers, Convention Student Activity Directors and Chairs, SA Coordinators, SA Committee Chairs and Committee Members have worked in unity to serve the teachers, parents, and more than 16,000 students who are affected by TMTA's student activities.

Some of our events have a significant increase in participation this year. The SA Performance Contest, with Semi-Finals on Thursday, has an increase of 50 students and 22 teachers.

Several of our TMTA Convention Student Activities show a significant increase: All-Star from 228 last year to 303, Convention Projects from 52 to 66, and Ensemble Contest from 2 to 13. We have a 33 percent increase over last year in graduating high school seniors receiving awards. Our Student Award boards are professionally printed this year.

Since June 2008, I have:

- Chaired committee to develop new TMTA Ensemble Contest. The completed proposal was passed at the TMTA Board Meeting on August 23, and has been posted on the TMTA website since that meeting.
- Attended required TMTA Officer meetings and conference calls.
- Directed completion of the TMTA Online Music Appreciation Program for grades 1-12, which will be posted on the website.
- Attended state and South Central Division MTNA Performance Competitions, serving as a monitor. While at MTNA Convention, attended all auditions, performances, and award ceremonies for our Texas student competitors.
- Chaired Student Affiliate Mid-winter Meeting in Houston on January 3.
- Located additional convention space for the All-Star Festival and worked closely with TMTA Director Naulene Pittman and Chair Beverly Ryan to assure this year's Festival will be a success. Together we designed the new gold and silver medals that will be presented at this year's Festival.
- Reviewed articles from SA Coordinators and TMTA Student Activity Chairs for *Prelude* ezine and *TMT* and forwarded articles to President Elect.
- Proofed Fall and Spring Theory Tests, and Answer Keys, which now have uniform templates. Answer keys and ear training CD's are available for teachers to purchase.
- Worked with other TMTA Officers to assist TMTA teachers suffering financial challenges following Hurricane Ike.
- Worked with SA Coordinators to update job descriptions and Handbook revisions for both the 2008-2009 and 2009-2010 TMTA Handbooks.
- Answered numerous emails and phone calls regarding various Student Affiliate and TMTA Student Activities.
- Prepared presentation for TMTA Leadership Conference for Local SA Chairs.

## **Student Affiliate Publication Competition Annual Report**

**June 1, 2009**

We had many wonderful submissions to the Publication Competition this year. Sixteen associations entered this contest with the most students entered by Plano (22) and Grand Prairie (20).

Judges for this year's competition were Maridell Fryar, who holds a BA degree from Hardin Simmons University and an MA degree from Texas Tech University; Horace Griffin who holds a BA in English from Southwestern University Georgetown and an MA in Speech from Texas Tech; and Michelle Johnson who earned a BA in Mass Communications from UTPB and an MA in Education from UTPB.

Winning articles will appear in the fall or spring issue of the "TMT". Winning and Outstanding articles will be published in this year's publication book.

This year's Winners and Outstandings will receive their certificates (and cash awards for Winners) at the awards ceremony to be held at the state convention this summer. The Publication Awards Program will be held on Saturday, June 13, at 5:00 pm in the Regency Room of the Hyatt Regency.

Out of 90 students entering, 14 received ratings of "Good", 33 received ratings of "Excellent", 25 received ratings of "Outstanding", and of course, 12 received ratings of "Winner".

Six students were disqualified for reasons such as not meeting the word count criteria. Some of the students who were disqualified for this reason did not see the rule which states that the title is included in the word count. One of the disqualifications occurred for writing on the wrong grade level. It was later discovered that this error occurred because the teacher wrote down the wrong number of the student's grade.

I have requested the following changes to the rules: (1) do not send me digital photos or hard copy photos until I request them. When I do request them, you may send them via e-mail or regular mail. I will then send the photos to the Student Affiliate Booth Coordinator who is responsible for the student awards boards at the convention, and to the editor of "TMT". (2) Only submit hard copies (paper) of essays, bibliographies, and discographies. Later, if your student is a Winner or an Outstanding, I will request that you send me an **e-mail attachment** of the article, bibliography, and discography. I will then burn one CD of these documents to send to the home office. Trying to keep up with all of the photos and CDs was an unnecessary burden. (3) No articles will be returned. If judges have remarks to make, they will put them on the critique sheets.

Templates for tests on all levels were formatted so that the tests are uniform in appearance and style.

This year saw the beginning of the use of CD's for the Ear Training portion of the Theory Tests. In the Fall, complimentary CD's were sent to every association. In the spring, CD's were only sent to Associations that requested them. All CD's have been sold at this time.

A new process for recording scores was initiated this year. Based on the TMTA database and score sheets prepared by our TMTA staffer, Abby Billins, the scores were typed online in the Fall by the Recorders, and typed in the Spring by the Head Graders. Once scores were typed, the results were sent instantly by email to associations and to the Coordinator. Some typing mistakes were made, but these were caught by the Association Chair and reported back to the Coordinator and to the TMTA office. Printouts of the reports were sent to the Associations in early May, and almost all medals were distributed by the first week of May.

Student Affiliate registrations have remained the biggest obstacle to easy records. We are recommending that no student will be allowed to take the Theory test unless registered in S.A. by the Fall deadline and the Spring deadline. To expedite this process, the Fall testing period will be changed to October 25-November 15. The Spring testing period will be changed to January 24-February 14.

**Problems:** Division 4 tests were written using old texts resulting in numerous questions. In spite of many concerns, this had little impact on the scores. Teachers, local chairs and all graders were notified to be lenient on grading certain questions as a result.

Reports from TMTA office have not evolved to the level of the pre 2007 level of usefulness.  
**RECOMMENDATION:** That the coordinator be sent a report that includes all grades available for all students, for present AND past years.

Division 1 tests used graphics from new texts that did not coincide with “Peter and the Wolf” graphics. Graphics of instruments were not labeled as had previously been done. **RECOMMENDATION:** That a decision be made as to whether it is necessary to label the instruments. **RECOMMENDATION:** That graphics specific to “Peter and the Wolf” be taken from that portion of the book. **OR RECOMMEND THAT** the graphics for “Peter and the Wolf” be changed in the text to the more accurate depictions used in the instrument section of the book.

Some committee members serving as proofreaders for the year 2008 - 2009 failed to communicate editing corrections to the coordinator and test writers as required by the position. As this is the most crucial portion of the test writing, **RECOMMENDATION:** All proofreaders be called together, either in person, such as at convention, or by conference call, or by e-mail with receipt requested and instructed as to what their specific duties are.

E-mail addresses that are changed during the year causing problems with communications. **RECOMMENDATION:** Coordinator shall send a receipt requested e-mail to all committee members and verify receipt. If there is not receipt returned, than coordinator shall communicate by telephone or regular mail with signature requested.

### **NEW FOR 2009**

Newly revised, reformatted texts were presented at the 2008 TMTA Convention. They were received with enthusiasm and wide acceptance.

Coming this year, in the near future, an online supplement to World of Music. This is a well thought out program that will have students looking forward to learning more about all aspects of music and composers lives. Listening will be enhanced by using the many resources available on the internet. Students may be rewarded by their teachers and/or parents for completing each unit.

Beverly Ryan will be the new coordinator as my term expires this year.



## Certification Report June 2009

### **General**

Eight TMTA members are currently in the process of working toward certification.

Five teachers have become certified since the 2008 Convention, and four teachers took the certification exam on May 1, 2009. Assuming they pass, the total number of teachers certified since June, 2008 will be nine. Statements and photos of newly certified teachers are featured on the certification page of the TMTA website.

For the calendar year of 2008, Texas had the greatest number of certifications of all the states with 12 new certifications.

### **Actions**

The list of twenty NCTMs who are willing to mentor certification candidates is in place, and three have been assigned to assist candidates through the certification process.

Everyone who attended the Certification Session at the 2008 TMTA Convention and who signed up at the booth was sent several email greetings with the entire certification packet attached.

A Certification Information Session was scheduled in San Antonio on October 3, 2008. Sixteen teachers attended and 12 of them have either begun or completed the certification process.

I created a PowerPoint presentation on the certification process which was emailed to local association certification chairs and presidents.

I attended meetings at MTNA for state certification chairs to learn about the completely new certification procedure. There are two certification sessions scheduled for this TMTA convention to explain the new procedure.

### **Goals**

Communicate more effectively with local association chairs to increase awareness of certification and its benefits.

Continue to improve number of NCTM renewals and the number of College Faculty pursuing certification.

Communicate with college pedagogy faculty to encourage them to enable students to meet new certification requirements through class assignments.

## TMTA Trustee Report

12 May 2009

It was indeed gratifying to see the many individual and association contributors to the Hurricane Ike Fund. Those individuals contributing were Lora Lynn Christensen, Janelle Schlaudt, Amy Andrus, Ruth Pittts, Irene Waters, Natalie Eustace, Roberta Gober, and Tena Hehn. Those Associations contributing were Victoria, Houston, Abilene, San Angelo, Brazos Valley, Louisiana, Plano, Corpus Christi, El Paso, and Music Teachers National Association. There was \$6,441.00 raised and with the additional funds from the TMTA Teacher Enrichment Grant (see Handbook, page 12, #3), we were able to distribute \$7,700 to teachers and students who had suffered loss during the hurricane. This took the form of grants for damaged instruments and equipment, lost wages, music, and supplies for both teachers and students. We are indeed an organization who looks after its' own in times of need. Congratulations to all of our generous contributors.

We had to put our plan of a web broadcast featuring a Martha Hilley workshop on hold but we understand more work on this project will occur this summer. We encourage all of you to nominate candidates for the Texas Teaching Fellow. This provides funds for the needs of the membership, both educational, physical, and professional. We did not have any Texas Teaching Fellows this year. This may be in part due to the economic slowdown.

The Teacher Grants were given to two very deserving recipients, Dr. Rozalie Levant and Dr. Macchioni. They both received grants of \$1,500 each to present at the World Piano Conference in Novi Sad (Serbia), May 4-8, 2009. Without the grants, they would not have been able to attend and represent TMTA so well.

The TMTEF Trustees monitor, oversee, and make decisions concerning the distribution of the various funds within the Foundation. Information is provide to the trustees by the VPBA and Frost National Bank Financial Managers. Additionally, the Chair acknowledges donations to the Foundation and includes articles and information in the TMT to help keep the membership informed.

The Foundation funds provide substantial support to the following activities and awards given to our students at convention:

**Fargason Memorial Fund:** Helps fund the orchestra for the Fargason Concert.

**Morris Fund:** helps to fund the ensemble awards.

**Johnson Fund:** helps to provide the awards to the TMTA/MTNA solo winners.

**Travel Fund:** helps to send our state winners to divisional and national competitions.

**General Fund:** helps to fund the awards given to our many Student Affiliate winners, including the Senior Theory and World of Music Awards, the Senior Participation and Whitlock Awards, the \$2000 Collegiate Scholarship, as well as the various Composition, Publication and Performance awards.

We are pleased and grateful that several associations accepted the challenge given 2 years ago and have contributed \$5.00 per member to the Foundation, with \$3.00 going to the Fargason Fund and \$2.00 going to the Student Travel Fund. We have been able to contribute to the costs of the orchestra concert with MTNA winners and to assist with travel expenses for the students representing us at state, division, and national competitions with the Student Travel Fund.

As of May 15, 2009, 28 associations and many individuals have contributed to the Foundation. We hope more contributions will arrive before convention. Total contributions to the Foundation during this fiscal year (since 10/01/08) stand at \$ designated to the various Foundation funds as follow:

Fargason Fund:	\$3728.88
Johnson Fund:	\$100.00
Morris Fund:	\$85.00
General Trust Fund:	\$509.64
Student Travel Fund:	\$2294.00

Due to the problems of the market and the economy in general during this fiscal year, the funds' investments have not earned an increase. But because we limit the annual dispensing of the monies from the funds to 5% we are still in good shape. Since we made the change to the current objective in 2003, the total return has exceeded the 5% distribution. The excess over the 5% has been banked to consider inflation and to add some growth to the account.

We hope that all of our associations and all of our members will continue to give to these various Foundation funds, including the Fargason Fund, the General Fund, the Morris Fund, the Johnson Fund, and the Student Travel Fund. We must do our part to

help these funds grown to assure the continuation of our wonderful programs for the future.

We are delighted that we have an application for the \$2000 TMTEF Collegiate Scholarship. The recipient, Dorothy J. Yan, is a piano performance major at the University of Texas at San Antonio where she is a founding member of the collegiate chapter and is a co-presenter at this convention. She will graduate in the Spring of 2010.

Mention should be made that the orchestra for the 2009 Fargason Concert is costing \$12,420. We had to ask the TMTA Board of Directors to approve the additional amount of \$6420 that was not budgeted. Because MTNA has deleted concerti as part of the required repertoire for the MTNA Performance Competitions, we will no longer have MTNA winners for the Fargason Concert.

The board will begin research and study of how the money in the Fargason account will be used in the future.

## Best of State Chairman Heather Rathnau, NCTM

As previously announced, Abilene MTA earned the BEST OF STATE title for 2009.

The points were tallied as follows: Abilene received 89 points and the 2<sup>nd</sup> place association received 72 points. The Association in 3<sup>rd</sup> place received 29 points. Three applications were received: Abilene, Arlington and East Texas.

Abilene submitted a picture-perfect application and only listed 'acceptable' items for points on the application. 'Unacceptable' items that Associations continue to list are SA events under "Local Competitions", listing individual teacher recitals under "Performances by the Association", and listing new members to Associations who are not new to TMTA (5 points each which I verified through the TMTA office). I have been careful to check and verify everything under Section C through the TMTA Office.

During my tenure of service in this position, I added the following items to the application in hopes it would clarify things (application attached):

- At the top of the form under YEAR: **(a former winner of this award must wait two years before reapplying)**
- In Section A: **List names:** (under Attending TMTA Convention, Donating to TMTEF, Holding NCTM and Donating to MTNA)
- In Section B: One point awarded for each of the following Association activities (not individual teachers). **Student Affiliate events are not included in Festivals or competitions.**
- In Section B: Each local competition sponsored by the Association (**SA events not included:**)
- In Section C: Supporting MTNA through a contribution for MTNA Fellow (or other - please describe) - this was added per suggestion by Sherry Frush, NCTM.
- In Section C: ***\*\*New Members must be new to TMTA\*\****
- Please list any other information, below, that may be relevant to your Association, support of TMTA or support of MTNA that may be taken into consideration. - this was added per suggestion by Sherry Frush, NCTM.

By asking members to "list names" for certain items, I was able to verify the accuracy of the applications. Discrepancies between what was submitted on the application and the TMTA records often surfaced. The biggest discrepancy continues to be the listing of New Members since quite often "new" members may be new to the Association, but not new to TMTA. This continues to be the most heavily-weighted question on the application with 5 points given for each new member, so I knew it was very important to verify this information. (After verifying this information, the Association initially in first place often dropped to second place).

I also informed the TMTA office, before the Convention, that the Best of State ribbons are only for teachers in the winning association, NOT the SA students and parents who also attend the Convention. (This was a problem one year).

I sent out an announcement to Abilene MTA and the other associations that applied, and I wrote articles for the TMT.

It might be nice to allow associations to submit these applications online. Andrea might need to work with the form to allow applicants to type in needed information.

I believe I have conducted this tally fairly and accurately each year. I am very proud of all the associations in TMTA that submitted applications. They are all doing such outstanding work! I consider all of the entries a winner, but unfortunately, I could only choose one based on information submitted.

I am privileged to have served TMTA in this position for the past three years. It is important to emphasize to the next chair that information must be verified as much as possible. I will be more than happy to help the chairman that follows me in this position.

**Ensemble Music Contest - Paul Boyd, Chair**

This event is only in its third year and participation has increased since last year. This was likely due to suggestions for new Piano Duo/Duet categories that were approved by the Board last June. A Division of Mixed Ensemble into Jazz and Classical music was undertaken in order to have like groups competing against each other instead of asking the judge to compare completely different styles of music. There were no entrants this time, however, in the Jazz category. This was more than made up for the increase in overall participation from 2 ensembles to 13. As this year's winners receive recognition within their MTA's and in state publications, it is anticipated that additional interest will be generated. In the future, a number of these new participates are likely to return to the convention.

The number of inquiries from participating teachers was extremely low, indicating that improvements to the categories, guidelines, and forms increased understanding significantly. There were no late entrants. The deadline change necessitated by the website problem was the primary problem as other pressing deadlines afterwards remained the same.

Again, this event needs to be taken to the local associations with more publicity to increase the number of participants.

He has performed with the Houston Grand Opera, the Houston Sinfonietta and various ensembles around Houston. Mr. Moore resides in Houston where he directs the 300-plus member guitar program at Bellaire High School.

**Commissioning Program Chair – Mona Rejino**

1. **GENERAL COMMENTS:** For the 2010 TMTA Commissioned Composer Program, the new process for voting was continued. Recordings alone were used to determine the winner. Composers' recordings were assigned alpha-numeric ID, and voting members voted by ID, not by a composer's name.
2. **ACTIVITIES & PARTICIPATION:** This year's winner was Debra Scroggins of Richardson. There were ten nominees from 11 different MTA's (two associations nominated the same person.) A score for the 2010 premiere is due to the Commissioned Composer Chair by February 15, 2010. Ms. Scroggins' work is scheduled to premiere in June 2010 at the convention in Arlington. The paperwork and contracts for Pierre Jalbert, the 2009 Commissioned Composer, have been submitted to MTNA headquarters. A check has been issued by MTNA for their half of the monies to be given to Mr. Jalbert at the 2009 TMTA Convention in June.
3. **UPCOMING ACTIVITY:** I will submit an article for the next Texas Music Teacher congratulating Ms. Scroggins and summarizing the events of this year's commissioning.
4. **ADDITIONAL COMMENTS:** I will be resigning as Commissioned Composer Chair effective August 1, 2009. A successor for 2010 has not yet been determined, but is in the works.

Since the Foundation Fellow program began in 2002 Texas has honored twelve of its members. Members honored in previous years include Martha Hilley, Pat Powers, June Leondar, Betty Hood, Irene Waters, Priscilla Heard, Laurel Ince, and Frances and Edwin Key.

Texas is ranked 27th of the 51 state associations in percentage of individual members'

donations. I would like to see us do much better in this area. On the other hand, we can be proud of the fact that we are 2nd out of 51 in the highest dollar amount given to the Foundation.

## **Arts Advocacy and Awareness Chair - Elizabeth Gutierrez, NCTM Board Report 2009**

1. General comments – Since I began as chair 2 years ago, I have become increasingly fascinated with the state of the arts and arts education in TX. My heightened awareness of events occurring in our state legislature convinces me that TMTA and all its members MUST remain knowledgeable about what is happening politically and be poised for action and communication with our lawmakers about the importance of arts education for ALL Texas students.
2. List of activities:
  - Represented TMTA at the TCQAE (Texas Coalition for Quality Arts Education) meetings - August 2008, December 2008, and May 2008.
  - Wrote a GoArts article and submitted a GoArts ad for TMTA's E-zine, *Prelude*.
  - Wrote an article for Winter issue of the TMT, though it was bumped by accident.
  - In April I sent an email blast to the TMTA Executive Board, all local association presidents, and some college faculty regarding the recent legislative bills SB3/HB3 and their intent to remove the fine arts requirement from TX high school graduation. The leadership at the Capitol heard your message of support, but the bills passed unanimously. As of 2011, one credit of fine arts will no longer be required for high school graduation (although schools must continue to offer fine arts).

The Senate passed an amendment by Senator Florence Shapiro to add a four-semester fine arts requirement for students in grades 6-8 (as of 2011). Further consideration of these bills is still underway as of this writing.

- An Arts Awareness/Advocacy booth and session will be presented at the 2009 Convention. Announcements about GoArts.org will also be made at

Convention Ensemble concerts and a General session, and members will be able to sign-up on the GoArts website as supporters of fine arts education for Texas students.

3. Information for the upcoming year:

So what can we do in future years to ensure that ALL TX students receive quality fine arts education? I will alert you if any further action is needed to protect the middle school requirement in the final version of the bill.

4. Total participation

- a. The number of TMTA members who logged on to the GoArts website this year is unknown. In the next annual report, I will report numbers of those who log in at the 2009 Convention.

5. Financial

- a. \$600 Donation to TCQAE

6. Awards presented

7. Evaluation

- a. TCQAE appreciates the annual support given to them by TMTA, but desperately needs additional contributions from private donors, businesses, non-profits, etc. to fund the group's fine work in raising awareness about the importance of the arts, especially among non-musicians. More individual TMTA members should become donors to this amazing coalition of TX arts groups. No other coalition in TX fights harder for the survival of fine arts in TX.

8. Suggestions for improvement

- a. Better involvement from local associations and teachers to support all Arts Education efforts. This can be done through local meetings using TCQAE's PowerPoint presentations and encouraging members to done to GoArts.org.
- b. The website page for Arts Awareness/Advocacy needs long over-due revision for better dissemination of information for our members and the general public.

**MTNA Collegiate Chapters Chair – Denise Parr-Scanlin**

We have two new chapters, one from Texas Christian University and one from the University of Texas at San Antonio. The Collegiate Chapters Conference took place during TMEA with the San Antonio chapter leading.

The students of the newly formed UTSA chapter presented a session on intermediate chamber music repertoire for piano and strings with 12 chapter members (piano, cello, viola, violin) participating. The session was well-attended and was also presented later in the week at the Alliance Music Teachers Association local meeting. We hope to see more attendance at next year's TMEA so a true Collegiate Chapter Forum can be held in 2010.

Also new this spring, several collegiate chapters from Texas are combining efforts to collect new and used music for teachers who lost their libraries during Hurricane Ike. The chapters have been given permission to have two booths in the exhibit at the June convention to make sure teachers from the affected areas have an opportunity to begin to replenish their collections. The UTSA chapter initiated the challenge, but other chapters were quick to rally and collected both scores and money.

Some of our Texas teachers were in attendance at the MTNA National Conference this year and participated in the Collegiate Chapter Forum. Those from Texas in attendance included Diane Delk, Martha Hilley and Kasandra Keeling with many other faculty and students from around the country. The topics of discussion included chapter activities, ideas for recruitment and the desire for increased student involvement in the planning of collegiate activities at the national conference. It was amazing to see so many groups of students there who were active in their chapters and a resource to their schools and communities.

### **College Faculty Forum Chair – Brian Marks**

The Collegiate Faculty Forum meeting at the MTNA national conference included several full and part-time faculty members from four-year universities (private and public) as well as junior and community colleges. Much information was exchanged about teaching loads, curriculum, administrative tasks, juries, etc. Among the many topics was a push to create a uniform piano proficiency curriculum for schools across the country. This was followed by more information exchange about class piano curriculum, piano proficiency requirements and textbooks. In attendance from Texas were Diane Delk and Kasandra Keeling.

## **Andrea Warren, NCTM – Website**

The TMTA web site has undergone some major changes this year. The hosting company was changed to a less expensive company so we are now paying \$4 per month instead of \$20. The site moved over to the new company in late February with a new design and organization plan.

We investigated using a program called Spreadsheet Converter to enable us to post Excel-type spreadsheet files online. We ran into some problems in implementation and ended up using a free service provided by Google Docs to process Performance Contest registrations. We may try to use the other program next year or investigate other options.

We now are offering online registration. We hired a freelance web designer to create our registration form for \$80. The data did not integrate as we had hoped, however, and we need to solve these problems before we offer this next year.

There have been three issues of the *Prelude*, each containing a variety of information. We will be working on more effective deadline dates for future publications. The *Prelude* has been sent electronically to all TMTA members.

(preregistration ended pretty strictly on May 20<sup>th</sup>. Only a handful have come in/been accepted since then. Last year, they were still coming in when we left for convention.)

**Database progress:** Don has made massive improvements to all aspects of the database. It seems that my wish is his command. If I ask for something, he'll do it.

- We've succeeded in creating an import for Theory scores and World of Music scores.
- We've cleaned up duplicate student records, we're working on removing duplicate member records (The import from MTNA is flawed, and he's working to correct that.)
- Member lists will be accurate when reports are run (currently about 700 members don't show up on the lists, and depending on which report you choose, different information comes up than what you're requesting the report to show)
- We've eliminated almost 500 phantom records (student information without ID numbers affiliated with them) to clean things up for a new database to be implemented this summer.
- New database should be able to include a functioning enrollment import (as was attempted in 2006 or 2007-before my time-but was unsuccessful)
- World of Music will finally be linked to enrollment in the new database and will be at the same level as theory, instead of just an add on that doesn't link to anything.
- New search options have been implemented for ease of use of the database, including: finding teachers' student lists without having to run an actual report, finding student records under each teacher instead of having to search just for individual students, email button next to teachers' email addresses for ease of contacting members in database, etc.
- Convention name badges have been changed in many ways. First, the badges should actually print the right way, which they didn't last year. Second, the year (2009) appears on the badges in the background (like a watermark), so it's more difficult for people to reuse previous years' badges. Third, the "badge name" accurately reflects the person's preferred name (for example: First name: Abigail, Last name: Billins, Badge name: Abby, shows up as:  
     Abby  
     Abigail Billins
- Many corruptions have been identified and corrected (some reports that worked last April, didn't work in August), including some security measures that were included in the old database (like "permissions" that we didn't have) we had just worked around, have now been removed.
- Online convention registration began this year, and has the potential to be a great tool in the future, but required many hours of extra work this year to gather the information reported on the registration forms. We were not able to capture any information electronically this year, and we relied entirely on the Google checkout emails we received to register people this year. We're hopeful that this process will be greatly improved next year, so we can be up to speed with online registrations, while improving the efficiency in the office as well. Don would like to work with Andrea to correct all issues we encountered this year, and to create an import for the information provided by the registrants.

**Office practices/policies streamlined:**

- Began online bill-pay to cutout some delays and inefficiencies.
- Changed phone service and postage meter to save money and reduce fees we were paying.
- Google checkout for convention brought its own challenges, we worked to remedy those challenges and correct bookkeeping errors that it created.
